

Davitran Networks SMS Alerts & Notifications – Terms and Conditions

These Terms and Conditions (“Terms”) govern your enrollment in and use of SMS alerts and notifications (“SMS Service”) provided by **Davitran Networks** (“we,” “our,” or “us”). By opting in to receive SMS alerts or notifications, you agree to these Terms. If you do not agree, please do not enroll in or use the SMS Service.

1. Nature of the Service

- Davitran Networks uses SMS messaging solely to provide informational alerts and notifications, which may include updates, reminders, security alerts, or customer communications.
 - Davitran Networks is **not** an SMS carrier or service provider. The SMS Service is delivered through third-party telecommunications providers, and we are not responsible for transmission delays or errors outside our control.

2. Eligibility

- You must be at least 18 years old, or have the consent of a parent or legal guardian, to enroll in the SMS Service.
 - By providing your mobile phone number, you represent that you are the subscriber or authorized user of the mobile number submitted.

3. Consent to Receive Messages

- By opting in, you consent to receive recurring SMS messages from Davitran Networks at the number you provide.
 - Consent to receive SMS alerts is not a condition of purchasing any product or service.
 - Message frequency will vary depending on your relationship with Davitran Networks and the type of alerts you subscribe to.

4. Costs and Charges

- Standard message and data rates may apply. Check with your mobile carrier for details about your plan and charges.
- Davitran Networks is not responsible for any charges billed by your mobile carrier related to your participation in the SMS Service.

5. Opt-Out and Support

- You may opt out at any time by replying **STOP** to any SMS message you receive from us. After you opt out, you may receive a confirmation message to verify your decision.

- Davitran Networks respects your privacy. Your personal information, including your mobile number, will only be used to provide SMS alerts/notifications and manage your subscription preferences.
 - We do not sell, rent, or share your phone number with unaffiliated third parties for marketing purposes.

- Delivery of SMS messages may be delayed or prevented by factors outside our control, such as your carrier's network availability.
 - Davitran Networks is not liable for delayed, undelivered, or misdirected messages.

- You may not use the SMS Service for unlawful purposes or in a way that could impair, damage, or interfere with the Service.
 - Misuse of the SMS Service may result in termination of your enrollment.

9. Changes to Terms

- Davitran Networks reserves the right to modify or update these Terms at any time. We will notify you of material changes by SMS or other reasonable means. Continued use of the SMS Service after changes take effect constitutes acceptance of the updated Terms.
